11	Subchapter J. Local Workforce Development Area Appeals, §802.170
12	
13	PART I. PURPOSE, BACKGROUND, AND AUTHORITY
14	The purpose of the Chapter 802 rule amendment is to add Subchapter J, relating to appeals of
15	denial of local workforce development area (workforce area) certifications. Subchapter J has
16	been added to this chapter to retain the rule related to workforce area appeals from repealed
17	Chapter 841, Subchapter E. This new subchapter is consistent with and implements the
18	Workforce Innovation and Opportunity Act (WIOA) §106(b)(5).

20	PART II. EXPLANATION OF INDIVIDUAL PROVISIONS
21	
22	SUBCHAPTER J. LOCAL WORKFORCE DEVELOPMENT AREA APPEALS
23	Consistent with WIOA §106(b)(5), TWC adopts new Subchapter J as follows:

25	§802.170. Appeal of Denial of Local Workforce Development Area Certification
26	New §802.170 states that all appeals of denial of workforce area certification shall be referred to
27	the Texas Workforce Investment Council.
28 29	TWC hereby certifies that the rule has been reviewed by legal counsel and found to be within
30	TWC's legal authority to adopt.
